What data do we collect?

Koinos collects the following data:

Personal identification information (Pseudo or First Name or Name, email address)

How do we collect your data?

You directly provide Koinos with most of the data we collect. We collect data and process data when you:

- Voluntarily complete our contact form or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Our Company collects your data so that we can:

- Email you to answer your contact message.

Koinos will not share your data to any other companies or persons.

How do we store your data?

Koinos securely stores your data in a server hosted in France, your data are stored in an encrypted database on Virtual server hosted within a secure infrastructure protected by a VPN and a secure authentication (certificate and password)

Koinos will keep your ID, email and messages for 1-year period. Once this time period has expired, we will delete expired data once by month by delete corresponding data in the data base and delete previous database back-up then create a new back-up.

What are your data protection rights?

Koinos would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Koinos for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that Koinos correct any information you believe is inaccurate. You also have the right to request Koinos to complete information you believe is incomplete.

The right to erasure — You have the right to request that Koinos erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Koinos restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Koinos's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Koinos transfer the data that we have collected to you, under certain conditions. We may charge you a small fee for this service.
